GUANGZHOU PORT

Guangzhou Port is located in the Pearl River estuary and the center of the Pearl River Delta area. Its water area covers five cities, namely Guangzhou, Dongguan, Shenzhen, Zhongshan, Zhuhai. Guangzhou Port consists of the harbor and the river port. The harbor has four parts, the Inner Port Area, the Whampoa Port Area, Xinsha Port Area and Nansha Port Area as well as the Pearl River Estuary anchorage. Its coastline is more than 400 kilometres and the planned port coastline is 108 kilometers, among which 60 kilometres are in use. The river port is one of the important river ports in Guangdong Province and it includes the Panyu Port Area, Wuhe Port Area and Xintang Port Area.



Guangzhou Port is an important hub for national integrated transport system, one of the major coastal ports and container mainline ports in China. It is also the main transshipment port for energy and supplies, important raw materials and trade goods in Guangdong Province. It is a strong pillar for South China and Southwest China to connect the international market and participate in the competition and cooperation of the international economy.

WHAMPOA OLD PORT

Whampoa Old Port is the starting point of the Ancient Maritime Silk Road. As early as the Qin and Han Dynasties (2,000 years ago), the Port had frequent maritime trade activities with other countries. In the Tang and Song Dynasties (1300 years ago), the shipping line to foreign countries from Guangzhou is the world's longest ocean route. In the Song and Yuan era, more than 140 countries and regions had trade links with Guangzhou. During the Qing Dynasty, Thirteen Trades Monopoly was the sole port in China and it took over the whole country's foreign trade.



BUILDING INTERNATIONAL SHIPPING HUB

Currently, Guangzhou is actively building itself into an international shipping center and shipping hub. Guangzhou Port will focus on improving business environment, port infrastructure and the collection and distribution system as well as promoting the modern shipping logistics and service industry for a smart, green and safe port. To deepen international exchange and collaboration, Guangzhou Port has established seaborne trade relationship with over 400 ports in more than 100 countries and regions and established Sister-Port relationship with 44 ports.



UPGRADING MODERN SHIPPING SERVICE INDUSTRY

Thanks to the advantage of Nansha Port Area with rich sources, Guangzhou Port will integrate the shipping service marketing sources within the range of Pan-Pearl River Delta. Moreover, Guangzhou Port will promote the construction of the Logistics Park, Bonded Port Area, and the development of port-vicinity industry. Guangzhou Port will dedicate to constructing comprehensive pilot zone for the international shipping in GD-HK-MC and build itself into a clustering area with advanced shipping elements.





Guangzhou Port has completed the construction of a group of large-scale specialized berths successively, including: the phase I, II and III of Nansha Port Area, Ro-Ro Terminal of Shazai Island, Petroleum & Chemical Terminal of Xiaohu. Guangzhou Port has direct shipping lines to Europe, North America, Australia, the Red Sea, and Southeast Asia, etc. It has initially formed the special waterway transportation system for container, coal, petrochemical, Ro-Ro vehicle, and grain etc.

LOCATION

Guangzhou Port is located at the geometrical center of the Pearl River Delta, with its 1 hour logistics circle with less than 100 km radius covering the Pearl River Delta region .The construction of the Navigational Channel Phase II and III Project qualifies the navigational channel, which was dredged to -17 meters, to accommodate the world's largest container ships.

DISPATCHING SYSTEM

Superior area environment provided economic hinterland and vast space for the port where the waterways, railways, highways and airlines conjoin. With the exceptional advantages, the port has spread services to Southeast Asia, connecting with international transportation network of navigation, aviation, railway and highway.



DEVELOPMENT OF NANSHA PORT AREA

Guangzhou Port is implementing the strategy of Expanding to the South of Guangzhou, and dedicating to accelerating the development of Nansha Port Area. At present, Nansha Port Area has 16 deep-water berths for containers. It can receive the world's biggest container vessels. Nansha Port Area has completed 300,000 DWT Ship-building Base. Rapid development has been attained in the operation of the Nansha Pilot Free Tade Zone, the Nansha Bonded Port Area and the Bonded Logistics Park.

STRENGTHENING PUBLIC SERVICE



Guangzhou Port centralized the management on the navigation channel, pilot, anchorage and communication scheduling, which ensure the order of inbound and outbound vessels and navigation safety. The application systems for administrative management are adopted to realize the real-time dynamic monitoring. The transportation of materials for important and emergent needs has been strongly secured.

II. Standard booth instructions

Design sketch of shell scheme (only for reference, subject to final confirmation of the organizing committee)



1. Every 9 m² standard booth includes: wall panels, fascia board, 2 long-arm spotlights, 1 information counter of 1mL*0.5mW*0.75mH, 2 white folding chairs, 1 socket, 1 waste basket, fireproof carpet

2. Maximum electricity power of every standard booth is 500W, only for laptop or small demonstrated exhibits use.

3. It is prohibited to connect high capacity electric appliance to the provided socket, violators will be punished with power cut and will be held accountable.

4. It is not allowed to dismantle or move all electric equipment installed at booth, not even take them out of venue. Please apply to the official contractor if you need high capacity power supply.

5. Clients who choose shell scheme can not change the structure or interior installations or cover the booth top with anything. Please apply to the official contractor if you need to change basic installations in advance, extra fee will be charged if apply or change on site.

6. It is prohibited to dismantle the display rack, exhibits; to hang or lean heavy stuff or picture frame directly on wall panels; to connect your own display rack or exhibits to the basic installations in order to avoid structure collapse.

7. Exhibitors shall take care of panels, exhibits and equipment of the venue. It is forbidden to install metal sharp nails or carve, scribble, drill, paint wall panels or exhibits. There shall not be any destructive adhesive tape or glue on your own propaganda material. It is prohibited to use KT board, foam, elastic fabric , mesh fabric or any decoration materials which do not conform to fire control requirements. All exhibits shall conform to fire control requirements and have fire protection. Any violators will be responsible for all resultant consequences.

8. The committee can make a certain degree of decoration on booth in order to enhance the overall effect, please comply with the committee if such situation occurs.



III. Raw space plan approval & on-site working registration procedure

Remarks:

Raw space exhibitors can designate your own constructor, or work with the constructor recommended by the organizing committee: GL events Live (Shenzhen). But all special booths must submit the plan to official contractor for structure security examination and approval. All booths must be examined and approved and must complete the registration procedure before entering in hall for construction. For those constructor who does not submit plan to official contractor, the organizing committee has the right to refuse his construction.

For those who have submitted plans and documents but are not approved or have some changes on the plans, please submit your modified or additional documents before/on 15th April 2019. If miss the deadline, a delay fee 2000RMB/booth will be demanded and construction time may be postponed as well.

5. Exhibits packing

We suggest that the exhibitors pack the goods in boxes for use when they are returned. To ensure that the cargo is not damaged during multiple loading and unloading, please fill, reinforce and support the case. We do not accept any claim for damage caused by the packing case itself. Please ensure that: (1) All packing cases are fixed with bolts, not screws and nails.





(3) If the packing box has no lifting point, it should have the fork point used by the forklift truck

(4) Please note that the ground is sometimes uneven, If the exhibitors hope to display the equipment on the crosser, they should cover the wood properly to protect the overall image of the exhibits.

(5) To reduce the risk of loss, damage and late arrival of the goods, please avoid packaging too small (it is recommended that the volume of each packing case is greater than 1 cubic metre, for example: 1 m x 1 m x 1 m). Exhibitors can combine several small cartons in a solid large box.

(6) Exhibitors are advised to prepare additional packaging materials (such as wrapping paper, plastic sheeting, etc., which are usually damaged when unpacking) with the goods in case of emergency.

(7) Packaging must be impact-proof and waterproof

As the goods will be kept outdoors repeatedly during the exhibition operation ,including the open storage at the exhibition site.it is recommended that the packing boxes should be strong enough and rain resistant. It is not recommended to use cartons that are non-repeatable and cannot be repacked.

If the goods are repackaged with used packaging materials, they will not be considered adequate impactproof or waterproofing materials. The consequences will be borne by the exhibitors.

(8) Overweight or oversized cargo

The exhibitor should arrive at the exhibition in advance in case of overweight or oversized goods, and be responsible for guiding the goods to be unpacked and in place. If you need to rent the crane or forklift separately, Including removing the base of the machine, etc. Please submit the detailed plan to us in advance, The cost is to be discussed separately. If you can provide detailed operational schematics, it will be more conducive to safe operation.

The outer packing box of such goods shall be fixed with bolts instead of nails and screws to prevent breakage and save operation time during unpacking (especially during the closing of the exhibition). Please mark the front and rear directions on the cargo box to ensure that the goods are placed quickly and safely.

6. Box surface marking

Please attach a minimum of four labels to the apparent location of each package.

If necessary, please add the following special box label to the appropriate place on the packing box:

(1) Fragile mark: mark on surface of all boxes.

(2) Mark the box with a sign to keep it in the correct position, and mark "THIS SIDE UP" on both sides of the box

(3) If the box cannot be kept outdoors, please mark both sides of the box with a rainproof (umbrella) sign.

(4) Cabinet or similar cabinet equipment should indicate where it can be hoisted and mark "SLING" at the right place



(5) If there is any space left in the box, the "SPARE PARTS" mark should be noted.

(6) To avoid unbalance when loading and unloading, clearly indicate the center of gravity, front, rear and lifting point outside the box. Other symbols and symbols shall comply with international regulations and norms

7. Requirements for wooden packing boxes and packaging materials for international exhibits

(1)It is forbidden to use old wooden box or already decayed wooden box. No log bark is allowed inside and outside of wooden box.

(2) Machine tool exhibits are packed with thick wood splints and fixed with screws, avoiding packing with iron nails.

(3)The China Inspection and Quarantine Agency will strictly require that wooden packing goods imported from all countries and regions must be treated with pest control.


(4)The range of exemptions includes wood materials for packaging that have been artificially synthesized or have been heated, pressurized, etc.(such as plywood, particleboard, fiberboard cores, sawdust, wood wires, shavings, etc., and wood materials of thickness equal to or less than 6mm).

(5)The imported goods with wooden packing, heat treatment (HT) or bromomethane fumigation (MB), shall be conducted in accordance with the International Plant Protection Convention under the supervision of the Government Quarantine Authority of the exporting country or region. And on both sides of the wooden packaging added IPPC special logo.The marker shall include the initials, country numbers of the International Plant Protection Convention, Unique number numbers and treatment methods of wood packaging manufacturers approved by official phytosanitary bodies abroad (e.g. bromomethane fumigation

- MB heat treatment-HT).

(6) If the wooden packaging does not apply a special IPPC mark or has applied a special mark but found live pests during random inspection and quarantine, the wooden packaging shall be treated or shipped back to the exporting country, and the responsibility and treatment costs shall be borne by the exhibitors themselves.

(4)All imported samples will be delivered and received at the booth.Our company will have special staff responsible for signing and receiving documents with exhibitors on the spot, including collection and distribution of packing cases and materials, additional logistics service, please ensure that the exhibitors sign and save the receipt of documents for reference.

(5)According to Chinese customs regulations, exhibitors are not allowed to bring any imported samples directly out of the booth before, during and after the opening of the exhibition. This kind of behavior is in violation of Chinese laws and regulations. We will not be responsible for the exhibitors' prosecution and punishment of any of the resulting customs and quarantine departments.

(6) The outer packing boxes and packing materials of the exhibits will be stored separately from the exhibition area.

Prints and catalogues of display exhibits, souvenirs and other small gifts that need to be distributed on the spot, CD-ROMs or video tapes that need to be broadcasted or distributed on the spot, and those also need to be declared in the Declaration List for Temporary Import Exhibitions. Samples of the above items should



(1)be submitted to our company in duplicate before the deadline on the timetable. It will be submitted to the Customs for examination in advance and considered for approval for public distribution. I.Basic regulations

1.Booth design must comply with professional technical norms (like electrical safety use, fire protection, structure, water supply and drainage, etc.)

Height limit of raw space overall structure is limited 4 meters. It is forbidden to build booth of 2 floors, violators will be punished with fines of doubled booth fee.

2.It is forbidden to damage, pollute or destroy in other ways the main building and ancillary facilities of the venue, including not to use nails or pile driving to fix objects on the ground or wall of the venue, not allowed to use materials which are difficult to remove like grease, paint, glue and so on, not allowed to lean, press, pull or hang on the walls, ceilings or any other special facilities and equipment (like pipes, embedded fitting, etc), and not allowed to suspend structural load-bearing objects on venue facilities without permission.

3.Carpet laid in public area, passage or booth must meet the difficult-flammable standard of level B1 or above, and the quality shall satisfy national environmental protection, fire prevention and flame retardant standards.

4.For constructing hard objects with sharp corners, decorative structures protruding or concave on the ground, ropes or cables that are dragged and dropped on the ground, and articles that are likely to cause crushing injuries, in the range of height or plane that may cause personal injury, protective measures and eye-catching warnings must be taken to prevent accidental injury.

5.Constructors shall apply for working pass for their workers, during construction period, all workers shall wear the working pass and observe the management. If not, the official contractor has the right to cancel the construction qualification of illegal workers.

6.During build-up and dismantling period, raw space constructors shall clean up special materials and garbage of booth within the specified time, official contractor will refund the deposit after check and confirm. otherwise the official contractor has right to deduct the deposit.

7.Constructors shall take necessary safety precautions according to relevant national laws and regulations to guarantee personal safety of booth construction personnel.

8. The wooden ladders is forbidden during the construction, high ladder of more than 2 meters must be guarded, top structures matching must use a lift. Temporary structures (walls) must be well fixed.

9.During build-up time, if raw space constructors need to work over time, they shall apply to official contractor before 16:00 of that day and go though over time working process.

10.All construction materials, decorative materials, carpets, light box cloth, and printing cloth must be non-flammable or flame-retardant and must reach flame-retardant standards of level B1 or above; it is forbidden to use flammable materials like polyurethane, foam KT board, flammable plastic products, ordinary sponges, elastic cloth, yarn products, soft bags and so on or other materials prohibited by fire fighting laws and regulations; the construction wood must use flame-retardant plates (level B1 or above) or fireproof coatings; decorative fabrics must be fire-retardant or be fully immersed in flame-retardant water to reach difficult-flammable standard of level B1 or above, it is necessary to provide material samples and product inspection report during construction application in order to prove that the materials have reached level B1 (difficult-flammable);

Constructors must use electrical materials of safety qualification, and meet national standards (GB), such as cables, switches, lamps and so on. For power wires and cables of equipment lines, except dark pipe laying,



11. Must use halogen-free low smoke wires and cables. When wires and cables are laid in bundles, must use flame-retardant wires and cables. Distribution lines should have protection measures like using metal pipes, enclosed metal trunking or difficult-flammable plastic pipes and so on. Installation of electrical equipment and facilities must comply with relevant technical requirements in < National Electrical Engineering Installation Standards>.

12.Overload use of cables and switches are not allowed. All loads of switches and cables used by constructors shall be limited within 80% of the nominal design capacity. If there are ageing signs on cables or switches or heating signs because of overload, official contractor and convention center have the right to cut off power and order rectification in order to avoid security incidents.

13.Except authorized personnel of exhibition center, others persons are not allowed to move, open and destroy the fixed power and lighting equipment and facilities in exhibition halls. Once discovered, it will be dealt with in accordance with relevant regulations.

14.During booth construction, constructors must reserve the distribution box interface to facilitate power connection and emergency repairs

15.Outdoor installation, use of electrical equipment, Lines and switches must have reliable protection, rain protection, grounding protection and warning measures.

16.If there are heating, frequent trips on lines or switches in booth, constructors must cut off the electricity timely and check. If these kinds of situations occur and caused by malfunction of cables, lamps or equipment of constructors, it is necessary to repair and change immediately. For example, except basic allocations, constructors have also installed other electrical equipment in standard booth without permission, or switch tripping caused by overloaded electricity use in special booths. It is necessary to declare the load and power again at the same time of rectification. For those who refuse to implement and cooperate, the power will be cut and there will be fines imposed.

17.During the build-up time, show time, and dismantling time, all kinds of construction materials and wastes must be cleared and transported within the specified time. If not, the garbage be cleaned up by the official contractor, and the garbage clearance fee will be deducted from the construction deposit paid by the booth constructor.

18.Construction personnel must be equipped everyone with helmet, and every special booth must be equipped with appropriate fire-fighting equipment.

II. Carpet protection regulations

Since the carpet of convention center is custom made, which is very precious and expensive, and the carpet replacement is extremely inconvenient, to avoid the carpet damage of the convention center, please follow the carpet protection regulations as below:

1.Before build-up time, the official contractor will lay a protective carpet on the original carpet of convention center, please pay attention and well maintain the protective, if there are some damages eventually to the original carpet of convention center due to the fault of special booth constructors, the compensation costs will be deducted by the official contractor from the cleaning&security deposit.

2.Special booth constructors shall put an additional layer of fireproof carpet on the carpet laid by the official contractor as the booth carpet, it is prohibited to use the official contractor's carpet as your booth carpet.

3.All kinds of construction vehicles or trucks are forbidden in the convention halls, you can use cart (with protective measures on the wheels) or hand haulage for construction materials transportation.

Special booth construction material requirements: "green exhibition construction materials" like aluminium materials, truss and so on are priority on the use of special booth construction materials. If there are some booths that really need to use wood as construction materials, it is necessary to disassemble the structure component in advance and then assemble on site. It is forbidden to process all materials on site. It



is forbidden to use nails, gun nails and other fixing materials to fix the wood components. And it is strictly forbidden to use oil paint and spray paint on site.

5. Tool requirements: All ladders, scaffolding, lifts and other work tools must use carpet protection measures at the bottom, it is forbidden to drag these work tools directly through the ground. If there are damages to the carpet due to violations, resultant costs will be assumed by the special booth constructor.

We've read through and are totally aware of <Construction management rules and regulations of Guanghzou Baiyun International Convention Center>, we are committed to strictly respect national laws and to comply with the <Construction management rules and regulations of Guanghzou Baiyun International Convention Center> to maintain on site security. We will bear economic or related legal consequences if there are violations to relevant national laws and regulations, or any safety problems and other accidents due to our improper design and construction.

Draft Minutes Annual General Meeting 1600 - 1730, Thursday May 9, 2019 Baiyun International Convention Center, Guangzhou, China

1. Opening Remarks by the Chair

IAPH President Santiago Garcia Milà (hereafter **the Chair**) opened the meeting by welcoming the attending members to the Annual General Meeting (AGM), which all IAPH members, Regular, Associate, Honorary and Temporary, are entitled to attend.

2. Declaration of Quorum

IAPH Secretary General Susumu Naruse declared that attendance by 35 Regular and Honorary Members in person and 30 by proxy (in total 65) satisfies the quorum for the meeting to transact business.

3. Approval of Agenda

The Chair presented the draft agenda and it was duly adopted.

4. Report on activities of IAPH during previous year and outlook for the next year

The Chair started his presentation by thanking the members present for having placed confidence in him to continue his third term as IAPH President. He then made some remarks on the activities conducted in the past years since the Baku conference in May 2018, with reference to the following topics.

- IAPH maintains a good relation with IMO, by referring to IAPH Vice-President for Africa, Mrs. Hadiza Bala Usman who was appointed Vice-Chair of the IMO Facilitation (FAL) Committee in April.
- Presentation of the new IAPH World Ports Sustainability Awards will be made during the Gala Dinner, 9 May.
- Regional meetings were held in three regions: Africa in Abuja, Nigeria, Asia South/West, East & Middle East in Kobe, Japan, and South/Central America in Panama City, Panama. More frequent interaction is desired to attract new members.
- From 2020, IAPH will utilize the service offered by HIS Markit for planning and managing the conference.

The Chair then proposed to work on **four goals** in the coming year to reinforce the transition process by mentioning:

(QUOTE) "**The first goal** is to have more frequent interaction with all that have an official role in IAPH. That means with all of you in the Council. I know budget



restrictions prevent frequent travelling, but I believe we should aim at having an annual working meeting of the Council, in addition to our traditional meeting during the conference. We need time to work on our agenda, meeting just once a year for two hours like we do now is not enough. We could for instance hold such an annual working meeting during an IMO session and combine it with a technical workshop on a topic that is high on our agenda.

The second goal is to work on our identity. The rebranding of IAPH is part of the strategic package but we need to make it a priority for the coming year, so that the World Ports Sustainability Program, the World Ports Conference and the new concept for the magazine Ports & Harbors are all clearly seen as part of a new and dynamic configuration.

The third goal is to have a professional membership drive. That means we must optimise the regional meetings, plan them well in advance and have them in locations that attract a maximum of existing and potential members. It also means that we should invest in a professional customer-relations management tool that can be used by all Council members that interact with existing and potential members.

The fourth and final goal is to optimise the use of our resources. With a new Board coming in, I want to take the opportunity to assess the resources we currently have and how we can allocate them better to our current and emerging needs. We also need a transparent organisation chart with clear lines of responsibility and reporting, in line with our constitution." (UNQUOTE)

Patrick Verhoeven, IAPH Managing Director – Policy and Strategy took the podium to give a progress report of the Strategic Package implementation since the Baku conference May 2018 by referring to the following specific projects so far conducted successfully including:

- Sustainability leadership UNCTAD workshop in March 2019 setting the roadmap for 2019-2022, 1st edition of World Ports Sustainability Award presentation and Women in ports mentoring launched in Guangzhou
- Climate projects IAPH cooperation with Canada in submitting a GHG and ports resolution to IMO MEPC74, IAPH Clean Marine Fuels Task Force, etc.
- Partner projects Survey on impact of extreme weather (PIANC), Joint event 2019 with ICHCA on cybersecurity, etc.

He cited the recently finalized report by Port Planning and Development Committee on automated vehicles and their impact on ports, new cruise committee agenda on cruise tourism, new IAPH branding/format for Ports&Harbors and website, membership canvassing to solicit opinions, etc.

In conclusion, he commented that there exists a clear need for us to mobilize manpower and establish a framework toward making IAPH more relevant and valuable so that we



can sell and promote IAPH. Also mentioned was the fact that funds were earmarked for the WPSP roadmap implementation.

Secretary General Susumu Naruse reported to the meeting the current financial status by commenting that the WPSP related expenses continue to account for a substantial and larger percentage of total expenses and the trend is obvious in the 2019 budget, due to the establishment of a special fund for the WPSP, i.e, about US\$ 1.2 million earmarked for WPSP for a period of four years (2019-2022). Regarding the current state of membership, he commented there still exists a decreasing trend of members and the resultant need to reverse it.

A question was raised as to how the WPSP funds are used, as an annual budget of Euro 297,000 is a big amount. In response, Patrick Verhoeven replied that funds are used for both projects and personnel.

5. Report on process and results of the elections of President and Vice Presidents and Endorsement by Members

Secretary General Susumu Naruse reported on the outcome of elections conducted from December 2018 to April 2019 to elect President and Vice Presidents for the next two-year term of 2019 to 2021.

The Chair inquired if there is any question or discussion regarding the Secretary General's report. Hearing none, he announced there will be a voting by ballot by Regular and Honorary Members in accordance with Article 36 of the Constitution to endorse the report. As a result of voting, the new line-up of the Board Members for 2019-2021 were duly endorsed, as per the attachment.

The Chair commented that the Secretary General will retire soon and the Board is in the process of selecting his successor in a clear and transparent manner and further thanked the Secretary General for his ten-year service to the Association. The comment met with a big applause. He further mentioned that as soon as his successor is appointed, it will be duly reported to the membership.

6. Election of Honorary Members

The Chair proposed three individuals nominated by the Board (as per the attachment) be elected for IAPH Honorary Membership and asked for endorsement by way of applause. As a result, Mrs. Monica Bonvalet (France), Mr. Martin Byrne (New Zealand) and Mr. Susumu Naruse were duly elected.

7. Presentation on the next Conference in Antwerp in 2020

Representing Port of Antwerp, Mr. Luc Arnouts, Director, International Relations & Networks, Antwerp Port Authority, took the podium to make a presentation on the IAPH conference 2020, Antwerp, Belgium, 17-19 March by showing a brief video.



After the presentation, a brief ceremony of changing hosts from Guangzhou to Antwerp was held, in which an IAPH flag was handed over from Mr. Chen, Director General, Guangzhou Port Authority to Mr. Luc Arnouts.

8. Other business

The Chair made a brief announcement to the effect that the venue of IAPH 2020 conference is still open and any port is welcome to host it.

With no further item to be discussed, the Chair adjourned the meeting.
